### **Notice of Publication of Eynsham Neighbourhood Development Plan Proposal. Regulation 16 of Part 5 of the Neighbourhood Planning (General) Regulations 2012 and Localism Act 2011.**

#### Statement of Representations Procedure and Availability of Proposed Submission Documents

#### **The subject matter**

Eynsham Neighbourhood Plan

#### **Details of the plan**

Eynsham Parish Council has undertaken extensive research and consultation to inform the production of a Neighbourhood Development Plan for the parish. The Plan sets out a suite of planning policies to realise a clear agreed vision for the future of the parish which states that: ‘Our vision for the Parish of Eynsham at the end of the plan period (2031) is that both new and existing residents will be enjoying the same benefits of living in the village as current residents do in 2017 and that the area will be an even more attractive community in which to live and work.’

#### **Procedure**

Following this statutory 6-week consultation period, within which representations can be made, West Oxfordshire District Council will submit these with the Eynsham Neighbourhood Development Plan proposal for Independent Examination. If successful at Examination, a referendum will be held. Should the referendum result in more than half those voting (ie 50% plus 1) West Oxfordshire District Council will ‘make’ the Plan and it will form part of the Development Plan against which planning applications will be assessed and determined.
