Nomination Papers must be delivered to the Returning Officer, at the Electoral Services Office, Council Offices, Woodgreen, Witney, Oxon, OX28 1NB, on any date after the date of publication of this notice, on Monday to Friday 9am to 5pm, but not later than **4 pm on Wednesday 2 April 2025**.

#### 4. POLL

Where any election is contested the poll will take place on **Thursday 1 May 2025**.

#### 5. APPLICATIONS TO REGISTER TO VOTE

Applications to register to vote must reach the Electoral Registration Officer no later than midnight on **Friday 11 April 2025** if they are to be effective for **Thursday 1 May 2025**. Applications can be made online at [www.gov.uk/register-to-vote](http://www.gov.uk/register-to-vote).

#### 6. APPLICATIONS TO VOTE BY POST OR PROXY

Applications to vote by post, or to vary or cancel existing postal or proxy voting arrangements, must reach the Electoral Registration Officer by **5 pm on Monday 14 April 2025**. Applications can be made online at [www.gov.uk/apply-postal-vote](http://www.gov.uk/apply-postal-vote).

Applications to vote by proxy at this election must reach the Electoral Registration Officer by **5 pm on Wednesday 23 April 2025**. Applications can be made online at [www.gov.uk/apply-proxy-vote](http://www.gov.uk/apply-proxy-vote).

Applications to vote by emergency proxy at this election must reach the Electoral Registration Officer by no later than **5 pm on Thursday 1 May 2025** telephone the Electoral Services Office (01993) 861521.

All applications regarding absent voting must be sent to the Electoral Registration Officer, Electoral Services Office, Council Offices, Woodgreen, Witney, Oxon, OX28 1NB.
