It will be noted that development on several of the sites listed in this appendix commenced a number of years ago and yet these are still shown as extant. Under normal conditions, once a material start has been made on a proposed scheme, there is no time limit for the completion of the work involved. Although the statuses of extant planning permissions are frequently checked, to ascertain when the relevant developments have been commenced or completed, it can sometimes be difficult to obtain definitive details without carrying out a site visit. These visits are carried out periodically, when resources are available, and particular attention is paid to any developments that have remained outstanding for extended periods. As a result of these visits, the detail in this appendix is being continually updated
