Basic Conditions Statement Submission Version – 28/07/2020



Section 1: Introduction & Background

- 1.1 This document is a 'Basic Conditions' Statement for the purposes of Regulations 15 (1)(d) and 22(1)(e) of the Neighbourhood Planning (General) Regulations 2012 (as amended). It has been produced by Charlbury Town Council to accompany the submission of the *Charlbury Neighbourhood Plan 2031 (Submission Draft)* ["the CNP"] to West Oxfordshire District Council ["WODC"] which is the local planning authority.
- 1.2 This Basic Conditions Statement demonstrates how, in the opinion of Charlbury Town Council, the CNP meets the basic conditions and legal requirements set out in paragraph 8 of Schedule 4B to the Town & Country Planning Act 1990 as applied to Neighbourhood Plans. Specifically, to meet these basic conditions the Neighbourhood Plan must:
 - a) have appropriate regard to national planning policy and guidance;
 - b) contribute to the achievement of sustainable development;
 - c) be in general conformity with the strategic policies of the West Oxfordshire Local Plan 2031;
 - d) be compatible with EU obligations.
- 1.3 The CNP sets out a positive vision for the future of the parish of Charlbury. The Plan aims to ensure that:
 - The views and needs of the local community shape and direct development in the parish.
 - The imperative to tackle the climate emergency is addressed in consideration of all development within the parish.
- 1.4 The aims and objectives of the plan, reflecting responses to the 2016 Town Survey and other public consultation, are set out in section 3 of the CNP. The policies within the CNP are designed to achieve these aims and objectives.
- 1.5 The CNP includes policies addressing sustainable development, local housing needs and economic, environmental and design priorities. There are specific policies for conserving and enhancing the natural and historic environment of Charlbury and policies, together with design principles, for the type, location and character of any development proposed.

- 1.6 Documents of particular importance to the drafting of the CNP and this Statement include:
 - The National Planning Policy Framework (Feb 2019) ["the NPPF"]¹
 - The West Oxfordshire Local Plan 2031 (Sept 2018) ["the WOLP"]²
 - The Cotswolds Area of Outstanding Natural Beauty Management Plan 2018-2023 (Oct 2018) ["the AONBMP"] ³
 - Planning Practice Guidance Neighbourhood Planning (revised 2019) ["PPGNP"]
 - Locality Neighbourhood Plans Roadmap (2018)

Background

- 1.7 At the request of the Town Council, an advisory group was set up in 2013 to produce a strategic plan for Charlbury. Membership of the group was drawn from the community and the group reported regularly to the Town Council. Following advice from WODC and ORCC (Oxfordshire Rural Community Council, now Community First Oxfordshire (CFO)), the decision was taken at that time to use the Community Led Plan (CLP) model for the plan but the option was left open to produce a separate Neighbourhood Development Plan should that be considered appropriate at a later stage.
- 1.8 During 2013 and early 2014, a series of public meetings, workshops and other events were held in the town to engage the community and to identify the issues and aspirations of importance to the people of Charlbury.
- 1.9 Subsequently it was decided that work should be taken forward in two streams under an umbrella group named the Charlbury Neighbourhood Forum⁴. One stream would prepare a Neighbourhood Development Plan (the CNP) and the other a Community Action Plan (CAP). Further details of this process are included in section 4 of the CNP and in the separate consultation statement.
- 1.10 Preparation of the CNP has been carried out on behalf of Charlbury Town Council by the Charlbury Neighbourhood Plan Steering Group. This group is chaired by a member of the town council. The steering group includes three town councillors (of whom 2 must be present at each meeting) and other co-opted members including two representatives from the Charlbury Conservation Area Advisory Committee.

- 1.11 To enhance the evidence base for the CNP, three pieces of work were undertaken at the request of Charlbury Town Council:
 - A Housing Needs Assessment for the parish⁵ commissioned from consultants arc4.
 - A Local Area Character assessment⁶ commissioned from Dr Kathryn Davies. Much of the work on this document was carried out by local volunteers under the guidance of Dr Kathryn Davies.
 - Assessments of locations to be considered for protection as Local Green Spaces⁷. This work was carried out by local volunteers using a toolkit developed by Cotswold District Council and recommended to the steering group by WODC.

Section 2: Legal Requirements

- 2.1 The CNP has been prepared in accordance with the statutory requirements and processes set out in the Town and Country Planning act 1990 (as amended by the Localism Act 2011) and the Neighbourhood Planning Regulations 2012 (as amended). It is being submitted by the Charlbury Town Council, which is the qualifying body as defined by the Localism Act 2011.
- 2.2 The CNP relates only to the Charlbury Neighbourhood Plan Area, which was designated by West Oxfordshire District Council on 17 September 2014 and is shown in Map 1 below and in section 1.5 of the CNP. The Neighbourhood Plan Area, which coincides with the civil parish of Charlbury includes the town of Charlbury, the settlement of Walcot and the surrounding rural area including outlying farms. There are no other neighbourhood plans relating to this area.
- 2.3 The CNP does not "constrain the delivery of important national policy objectives", indeed it assists in achieving them at neighbourhood level. Neither does it deal with county matters (mineral extraction and waste development), nationally significant infrastructure nor any other matters set out in section 61K of the Town and Country Planning Act 1990.
- 2.4 The Plan will apply from the date of its adoption until 31st March 2031 running concurrently with the West Oxfordshire Local Plan 2031. It is recognised that the concerns and priorities of local residents may change over this period. It may therefore be necessary to revisit and revise the plan from time to time. Charlbury Town Council, as the Neighbourhood Plan Authority, will be responsible for maintaining and periodically revisiting the Plan to ensure relevance and to monitor its delivery.
- 2.5 The legal and policy context of the CNP is also set out in section 1 of the plan itself.

Section 3: How the Plan Meets the Basic Conditions

3.1 General Observations

- 3.1.1 This section of the Basic Conditions Statement describes how, in the opinion of Charlbury Town Council, the Charlbury Neighbourhood Plan 2031 meets the basic conditions required for a Neighbourhood Plan as stated in paragraph **Error! Reference source not found.** Subsections 3.2 to 0 below cover each of the four conditions in turn.
- 3.1.2 The policies within the CNP are accompanied by supporting text which explains the context in which the policies are proposed including the "basic conditions" requirements and the relevant evidence base. To avoid duplication, references to this supporting text are included within this section where appropriate.
- 3.1.3 The Housing policies included in section 5 of the CNP have been formulated following in-depth consideration and analysis of a wide body of evidence and relevant planning policies, including those in the National Planning Policy Framework 2019 (NPPF) and the West Oxfordshire Local Plan 2031 (WOLP), as well as the Housing Needs Assessment (HNA) commissioned by the Town Council (Jan 2018). This analysis and consideration of the issues affecting Charlbury are set out in detail in the Housing Need & Policy Analysis, which is included as **Error! Reference source not found.** to the CNP.
- 3.1.4 The presumption in favour of sustainable development at Policy OS1 (and at paras 11-14 of the NPPF) is a given that underlies all the CNP policies. This is explored further in section 3.3 of this statement.
- 3.1.5 To avoid excessive duplication, the tables below contain summary commentaries but also include references to the sections, paragraphs and appendices within the CNP as appropriate, where further detail can be found.

3.2 Having appropriate regard to national planning policy and guidance

- 3.2.1 The CNP has been prepared with full regard to national policies as set out in the NPPF and is mindful of the Planning Practice Guidance (PPG) in respect of formulating Neighbourhood Plans. During the preparation of the CNP, two revisions to the NPPF were published, most recently in February 2019. Following these revisions, a review of the CNP was carried out to ensure compliance with the revised NPPF and to update references.
- 3.2.2 In line with NPPF paragraphs 13 & 29, the CNP seeks to "*shape, direct and help to deliver sustainable development*" within the parish having regard to the specific local circumstances, needs, challenges and aspirations of the town and community of Charlbury.
- 3.2.3 The following matters of general significance are reflected throughout the CNP:

- **Charlbury's location within the Cotswolds AONB**. In line with NPPF paragraph 172, CNP policies recognise the "Great weight should be given to conserving and enhancing landscape and scenic beauty" and that "the conservation and enhancement of wildlife and cultural heritage are also important considerations".
- The imperative to tackle the climate emergency. In line with NPPF paragraph 149, the aims and objectives of the CNP include "Aim 2: to address the challenge of climate change actively at the local level" (see section 3 of the CNP).
- 3.2.4 The housing policies set out in section 5 of the CNP, seek to deliver Aim 3 of the plan "*To ensure that development in Charlbury is sustainable and meets the town's local housing and employment needs*". This aim reflects NPPF ¶29 in seeking to "*shape, direct and help to deliver sustainable development*" within Charlbury to meet the needs of the town and community. The CNP emphasis on local needs reflects NPPF ¶77 which states that "*In rural areas, planning policies and decisions should be responsive to local circumstances and support housing developments that reflect local needs*". The policies also reflect Charlbury's location within the Cotswolds AONB and the special considerations applicable to such areas as defined in NPPF ¶172.
- 3.2.5 NPPF ¶69 recommends that "Neighbourhood planning groups should also consider the opportunities for allocating small and medium-sized sites suitable for housing in their area". As explained in CNP Appendix A (A.2), a "call for sites" was carried out but in view of revisions made to the WOLP following examination, a decision was subsequently taken not to allocate any sites but to adopt a "criteria-based" approach (see Appendix A Conclusion 1) reflecting the "more restrictive approach to new housing development" within the Cotswolds AONB adopted by the West Oxfordshire Local Plan 2031.
- 3.2.6 The following table summarises how specific provisions of the NPPF have been taken into account for each of the policies within the CNP. As well as identifying the relevant NPPF paragraphs, the table also includes references to sections, paragraphs and appendices within the CNP where further explanation may be found.

3.3 Contributing to the achievement of sustainable development

- 3.3.1 Paragraph 8 of the NPPF identifies three overarching objectives to sustainable development: Economic, Social and Environmental.
- 3.3.2 Key ways in which the CNP will contribute to securing net gains to these three objectives for sustainable development are:
 - The CNP sets out a positive vision for the future of the parish and community of Charlbury based on responses to the 2016 town survey and other public consultation.
 - The aims and objectives of the CNP [CNP section 3] overwhelmingly seek to secure a sustainable future for the town and community. The CNP policies are designed to address these aims and encompass economic, social and environmental matters.
 - The recognition (by the Town Council in particular) of a climate emergency has been a major consideration in the drafting of the Plan. In this regard, Aim 2 of the CNP is "*To address the challenge of climate change actively at local level*". This aim underlies many of the CNP's policies in relation to the natural environment [Section 7], transport [Policies ECT9-12] and energy efficiency [Policy NE9].

- The CNP takes a positive, criteria-based approach to the provision of new housing to meet the Parish's identified needs and thereby to support a sustainable future for the community, the town and its landscape setting. [CNP section 5 policies CH1 to CH10].
- The CNP recognises the challenges of an ageing population and the need to maintain a diverse and sustainable community. It also recognises that housing affordability is a major issue and identifies the types of housing needed to address these challenges. [Also CNP section 5 policies CH1 to CH10].
- The CNP supports the Charlbury's role as a rural service centre and seeks to protect and enhance local services, facilities and infrastructure [CNP Section 6 policies EHT1 to EHT6].
- The CNP seeks to promote walking and cycling and safe pedestrian access for all for a healthy lifestyle and the reduction of car journeys [CNP Section 6 policies ECT9 to EHT 15].
- The CNP supports the protection and enhancement of environmental and historic assets [CNP Sections 7 & 8 policies NE1 to NE9 and HE1 to HE3]

3.4 General conformity with the strategic local plan policies

- 3.4.1 The strategic local plan policies relating to the Charlbury Neighbourhood Area are defined in the West Oxfordshire Local Plan 2031 (WOLP), which was adopted in September 2018. For the purposes of the WOLP, Charlbury lies within the Burford-Charlbury sub-area (WOLP Chapter 9 Strategy at the local level) and is designated as a Rural Service Centre.
- 3.4.2 By the time that the WOLP was adopted, preparation of the CNP was well advanced so that much of the early work on the CNP was based on draft versions of the WOLP. However, Charlbury Town Council and the Neighbourhood Plan Steering Group kept in close contact with WODC during this time and actively engaged in the consultation processes for the WOLP.
- 3.4.3 Following examination and at the request of the examiner, revisions were made to the WOLP which included significant changes for the Burford-Charlbury sub-area. As a result, a significant review of the CNP was undertaken to reflect the WOLP changes. This review primarily affected the housing policies in section 5 of the CNP.
- 3.4.4 The most significant late WOLP changes for Charlbury relate to a revision of housing allocations for the Burford-Charlbury sub-area in recognition that the majority of the sub-area (including the whole of the Charlbury Neighbourhood Area) lies within the Cotswolds AONB and that, consequently, a more restricted approach to development was appropriate in this area. In particular, the housing allocation for the sub-area was revised downwards, four formerly proposed site allocations within the sub-area, including one in Charlbury, were removed from the plan and there was an increased emphasis on the need to reflect local needs within the AONB. Reflecting these changes, the decision was taken by the Neighbourhood Plan Steering Group that the CNP would adopt a "criteria-led" approach to housing focussed on meeting local needs and would NOT include any site allocations. The analysis leading to this decision is explored in more detail in the "*Housing Need & Policy Analysis*", which is included as **Error! Reference source not found.** to the CNP and the decision is summarised as "Conclusion 1" in that appendix and in section 5.1 of the CNP.

3.4.5 The table below outlines how, in the opinion of Charlbury Town Council, each of the CNP policies is in general conformity with the strategic policies of the WOLP. Chapter 2 (Overall Strategy) of the WOLP includes the main strategic policies (prefixed OS) but many of the other policies included in the WOLP may reasonably be considered to be strategic in nature, serving to meet the WOLP's clear expression of objectives in the opening Chapter 'Our Vision'. To reflect this, WOLP references in the table below are not restricted to the "OS" policies but include those WOLP policies that appear particularly relevant to the issues addressed by each CNP policy.

3.5 Compatibility with EU obligations

3.5.1 The Plan is compatible with EU obligations in relation to human rights, habitat protection and environmental impacts. Specifically:

- Where Local Green Space and Local Listing designations are proposed, consultation and notification of their inclusion in the Plan has occurred with the landowners concerned. Others potentially affected by the proposals have also been consulted and have had the opportunity to comment on them, as set out in the Consultation Statement.
- In accordance with requirements of European Directive 2001/42/EC, West Oxfordshire District Council prepared a Strategic Environmental Assessment Screening Opinion in January 2020 which concluded that a full Strategic Environmental Assessment of the Plan is not required. Specifically, at paragraph 5.3, the screening report stated: "West Oxfordshire District Council considers that the draft Charlbury Neighbourhood Plan (CNP2031, September 2019) is unlikely to have significant environmental effects and thus does not require a Strategic Environmental Assessment (SEA)".
- The District Council also confirmed via their Habitat Regulations Screening Opinion that no further Habitat Regulations Assessment (HRA) is required. Paragraph 6.2 of the WODC Screening Report includes the sentence: "*The HRA of the Local Plan remains valid and there is no new material and relevant information that should be considered*".
